## **Aggressive Dog Reports**

It is the obligation of each owner, exhibitor and handler at a show to take all such steps as may be necessary to ensure that any dog under that person's care or control or for which that person is responsible does not behave in an aggressive manner.

It is the obligation of any person at a show who observes a dog behaving in an aggressive manner to report the incident either orally or in writing to a member of the Show Committee as soon as possible after the incident.

## **Safety and Risk Notice**

Competitors are responsible for making their own determination that they are able to participate in this activity and handle their dog in the trial environment. All dogs must be under effective control at all times while on the grounds.

Handlers are required to wear suitable footwear that is closed-in, secure and in good condition. Footwear such as thongs, sandals or high heels are not permitted in or around the trial areas.

Competitors should remain aware of their surroundings and any potential hazards observed including uneven ground, weather conditions, equipment or other dogs. Any potential hazards should be reported to the Trial Manager or Secretary or any other official immediately.

First aid for both humans and dogs is located in the middle of the club house along with a defibrillator which is clearly signposted

Please do not obstruct emergency vehicle access

Hazardous areas are marked with orange cones

Beware sitting or parking under trees for possible falling branches.
